- Colorado evaluation fix- text wrapping issue has been corrected
- Graduation guidelines assessment logic has been modified to only report a record when the assessment is mapped to a test subject area
- Daily payment notification report as failing to send due to internal file attachment errors- this has been corrected
- Users who use time-based two factor authentication to log into IC and were logged out of the system were unable to log back in unless they cleared their web browser's cookie- this has been corrected

CDE Updates/Upcoming Collection Dates and Deadlines

- P-EBT- benefits extended through the summer of 2022
 - Plan received approval from USDA for SY 2021-22
 - Approval that allows for SY 2020-21 and Summer 2021 benefit corrections
 - Corrections include students who were unintentionally omitted from any previous P-EBT Data Collections through the CDE Pipeline or files submitted via syncplicity for NON-PUBLIC schools only
 - AND students who had an FRPL indication that was reported incorrectly
- CRDC Extended Deadline is now March 11, 2022
- ACCESS SBD (tentative) is March 18th-March 29th, 2022
- Assessments:
 - CMAS/CoAlt Testing Window: April 11-29, 2022
 - CO SAT:
 - Primary Test Date: Wednesday April 13, 2022
